Digital Attestation Service for Digital Documents

About the Service

This service provides digital attestation by the Ministry of Foreign Affairs and UAE missions in the destination country. Attestation is a procedure that verifies the authenticity of signatures and official seals on documents issued inside or outside the UAE.

The attestation method is determined based on whether the document is digital or non-digital.

Key Requirements

- The document must be issued in the UAE
- The document must include a verifiable feature such as a QR code, a barcode or a reference number

The following UAE-issued certificates

are attested digitally only:

- Birth Certificate
- Death Certificate
- Police Clearance Certificate (Good Conduct)
- Educational Certificates and Academic Documents
- Medical Reports and Health Certificates
- Marriage Certificates

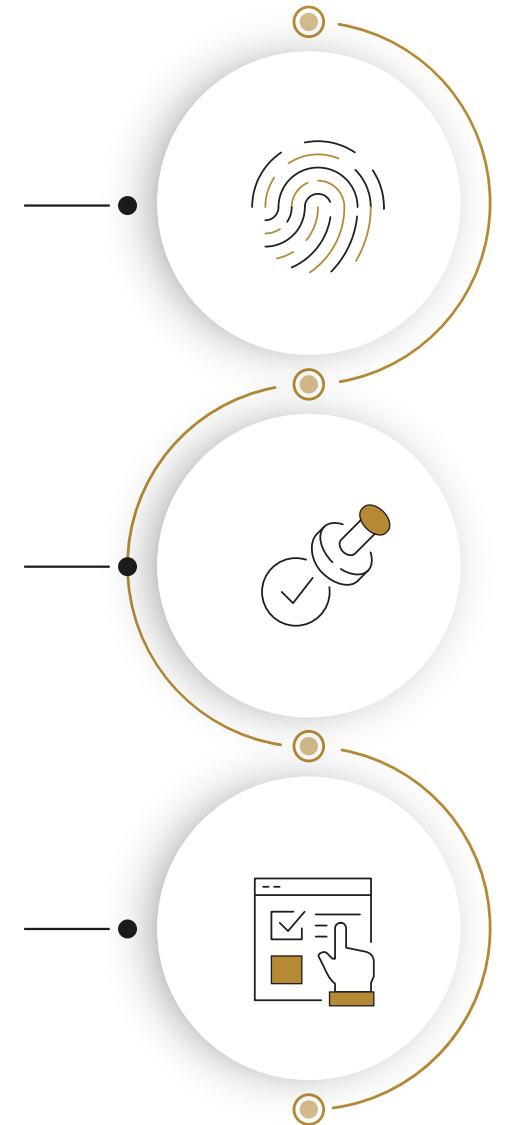
